

## TERMS AND CONDITIONS

- 1) Promoter - The promoter of the Unichem 25<sup>th</sup> Birthday 'Spend & Win' and 'Our Gift to You' is Pharmacybrands Limited. All information published by Pharmacybrands Limited on how to enter the competition forms part of these terms and conditions.
- 2) Entrants - The competition is open to all New Zealand residents who have made a valid purchase at a Unichem Pharmacy between 28<sup>th</sup> April 2008- 31 May 2008. Each entry must be completed on the back of a valid till or eftpos receipt.
- 3) Entries must be submitted in store in the entry boxes provided. Entries will NOT be accepted if the entrants name and phone number are illegible. There is no limit to the number of entries each individual can make.
- 4) Entry to the Promotion is deemed to be acceptance of the terms and conditions. Where multiple entries per day are made, they must be on original receipt of each different transaction.
- 5) The promoter reserves the right to refuse to award any prize to an entrant who Pharmacybrands Limited decides (in its sole discretion) has violated the terms and conditions, gained unfair advantage in participating in the promotion or won using fraudulent means.
